NEW ITEM: 4.0 General The DP shall not take actions which are: First; unchristian or inconsistent with Biblical and confessional standards; Second, in violation of law or applicable regulations or commonly accepted professional ethics; Third, in violation of stated Board policies.

- 3.1.2 The Board will delegate authority only to the District President, except for assignment of its own work to committees or consultants. Any other staff or group operating with the authority of the ED BOD shall receive that authority from the District President or a person designated by him.
- 3.1.3 The Board shall address Gov issues through policies of purpose and limitations. The President may develop operational policies, ministry guidelines or procedures and may make decisions in any way deemed fitting as long as the policies adopted by the Board are observed.
- 3.1.4 The authority of the District President shall begin where the explicit pronouncements of the Board end. Except as required by law, governance documents or existing policies, decisions by the District President do not need approval by the Board.
